**WAIVER OF LIABILITY**

Genevieve County, Missouri, its officers, employees and agents from any liability, claims, damages, demands, actions or causes of action arising from or growing out of any and all personal injuries or property damage which may occur due to an accident while the undersigned is operating an all terrain vehicle on the roads in Ste. Genevieve County, Missouri, including any liability occasioned by an accident caused by the ATV operator, or an accident in which I am involved which was not caused by me, and I agree to defend and hold Ste. Genevieve County, its officers, employees and agents, harmless from any and all liability occasioned as aforesaid by my operation of an all terrain vehicle on the roads of Ste. Genevieve County, Missouri.

I understand that this waiver extends to injury of any passenger(s) that I may have in an all terrain vehicle suitable for more than one passenger, and I will hold Ste. Genevieve County, Missouri harmless from any damages resulting to said passenger(s) either occasioned by the operator of an all terrain vehicle upon the roads of Ste. Genevieve County, Missouri or as a result of injury caused to said passenger by the acts of others.

STE. GENEVIEVE COUNTY, MISSOURI  
ATV PERMIT REQUIREMENTS

1. Each applicant shall be at least eighteen (18) years of age.
2. Each applicant shall provide a valid driver's license and shall maintain such during the permit period.
3. Each applicant shall show proof of paid personal property tax on the ATV that is being registered and shall maintain such during the permit period.
4. Each applicant shall produce proof of liability insurance on the ATV that is being registered and shall maintain such during the permit period.
5. Each applicant must sign a worn "Waiver of Liability" form that is designed by Ste. Genevieve County.
6. Each ATV that is registered shall have a bicycle safety flag that extends not less than seven feet above the ground. The safety flag shall be triangle in shape with area of not less than thirty square inches and shall be day-glow in color.
7. No ATV shall carry a passenger unless the seat of the ATV is designed for more than one person.
8. ATV speed limit is thirty miles per hour of less.
9. No ATV can be operated during non-daylight hours.
10. The ATV permit decal must be attached to the ATV for which the permit is issued. It must be attached to the yoke area of the handlebars.
11. An ATV permit allows for the ATV to be ridden on Ste. Genevieve County roads. It does not allow the ATV to be ridden on State lettered roads, highways or interstates.
